Section 4: Tax Deduction

The Government allows you to claim a tax deduction for personal contributions up to the concessional contributions cap.

If you intend to claim a tax deduction for your contribution, you must also complete the ATO's Notice of Intent to Claim a Tax Deduction and attach a completed Notice of Intent to this application or submit within the timeframes specified below. Note: All personal contributions made to Future Super will be allocated as non-concessional contributions, and will count towards your non-concessional contributions cap, unless and until such time that a notice of intent to claim or vary a tax deduction form is received. Claiming a tax deduction for your contribution makes this contribution ineligible to be counted towards the Government Co-contribution.

If you are aged between 67 and 75 and intend to claim a tax deduction for this contribution, you must meet the Work Test of being gainfully employed for at least 40 hours in 30 consecutive days in the current financial year or be eligible for the Work Test Exemption. The ATO will record your eligibility for the work test when you submit your tax return. Please note that you must submit a Notice of Intent to Claim a Tax Deduction before you lodge your tax return.
